# A RESOLUTION APPROVING INVENTORY CHANGES IDENTIFYED IN THE APPROVED LONG RANGE TRANSPORTATION PLAN DEVELOPED IN 2013 FOR THE BUREAU OF INDIAN AFFAIRS TRIBAL TRANSPORTATION PROGRAM

WHEREAS, the Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point; and

WHEREAS, the Qagan Tayagungin Tribe qualifies for services and benefits under the Tribal Transportation Program; and

WHEREAS, the Bureau of Indian Affairs (BIA) is responsible for updating the Tribal Transportation Inventory; and

WHEREAS, the Tribe has identified a need to update its inventory; and

WHEREAS, the Tribe has identified these roads as vital to the general health and welfare of the native community and its economic development; and

WHEREAS, the Tribal Council has identified priorities for its Tribal Transportation Program; and

WHEREAS, the Tribe has updated its long range transportation plan accordingly.

WHEREAS, the Tribe has submitted this plan and inventory changes to the Bureau of Indian Affairs Department of Transportation for inclusion in the FY2014 Tribal Transportation Inventory; and

WHEREAS, the Bureau of Indian Affairs Branch of Transportation has requested the following changes be documented as approved via tribal resolution;

NOW THEREFORE BE IT RESOLVED, the Qagan Tayagungin Tribe of Sand Point hereby approves the changes listed in Attachment 1, to include with the FY 2015 Inventory Submittal.
