RESOLUTION 18-09

A RESOLUTION OF THE QAGAN TAYAGUNGIN TRIBE AUTHORIZING THE SATORI GROUP TO COME TO SAND POINT FOR ASBESTOS ABATEMENT AT THE COVERED BUNKER UNDER NALEMP

WHEREAS, the Qagan Tayagungin Tribe is a sovereign federally recognized tribe with government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point; and

WHEREAS, the United States Army Corps of Engineers administers the Native American Lands Environmental Mitigation Program; and

WHEREAS, the Qagan Tayagungin Tribe of Sand Point is authorized to contract for and provide certain federal and state programs; and

WHEREAS, our land is valuable to the beings of our community and the Qagan Tayagungin Tribe strongly supports the research, mapping, education and removal of hazardous materials and military debris; and

WHEREAS, The US Army Corp of Engineers through the NALEMP program has provide the Qagan Tayagungin Tribe funding through a cooperative agreement to hire a contractor to perform the Sand Point Naval Bunker Abatement of Asbestos; and

WHEREAS, The Qagan Tayagungin Tribe received one proposal in response to a suggestion from the US Army Corps of Engineers; and

WHEREAS, the Executive Director and Program Manager and NALEMP Project Officer reviewed the proposal; and

WHEREAS, the Executive Director and Program Manager have recommended to the Qagan Tayagungin Tribal council to offer a contract to the Satori Group; and

WHEREAS, the proposal from the Satori group was in the amount of \$8,800; and

WHEREAS, the funding for this project will be covered by NALEMP.

NOW THEREFORE BE IT RESOLVED, That the Qagan Tayagungin Tribal Council hereby approves the Satori Group to come to Sand Point for Asbestos Abatement at the covered bunker located in the Sand Point Spit Backtrails; and

BE IT FURTHER RESOLVED, that the Tribal President is hereby authorized and instructed to sign this Resolution and all necessary agreements and contracts for and on behalf of the Tribe in order to enter into a contact with the approved bidder.
