**RESOLUTION 01-02**

**A RESOLUTION AUTHORIZING THE ALEUTIAN HOUSING AUTHORITY ("AHA") TO REPRESENT THE QAGAN TAYAGUNGIN TRIBE AS ITS TRIBALLY DESIGNATED HOUSING ENTITY ("TDHE") PROPOSED UNDER THE NATIVE AMERICAN HOUSING ASSISTANCE AND SELF-DETERMINATION ACT OF 1996 ("NAHASDA").**

**WHEREAS,** the Qagan Tayagungin Tribe of Sand Point is a federally recognized tribe with a government to government status with the United States of America, and

**WHEREAS,** it is the intent of the Qagan Tayagungin Tribe to take an active role in the tribes Indian Housing Plan; and

**WHEREAS,** the Qagan Tayagungin Tribe will take a more active role by reviewing the IHP prior to submission by the TDHE, and

**WHEREAS,** the Native American Housing Assistance and Self-Determination Act of 1996 ("NAHASDA") has changed the nature of funding for Indian Housing, and beginning October 1, 1997, a single-block grant program will replace the various funding sources now available for Indian housing, and

**WHEREAS,** the new block grant funding will be available to tribes, only if the tribe has submitted and received approval of an Indian Housing Plan ("IHP"), and

**WHEREAS,** the Qagan Tayagungin Tribe wishes to make the Aleutian Housing Authority ("AHA") its Tribally Designated Housing Entity, ("TDHE") with full authority to submit an IHP and receive tribal funding, and

**NOW, THEREFORE BE IT RESOLVED,** that the Aleutian Housing Authority is hereby made the Tribally Designated Housing Entity for the Qagan Tayagungin Tribe. Appropriate officers of the Aleutian Housing Authority are authorized to execute the attached certification.

**BE IT FURTHER RESOLVED,** that the Aleutian Housing Authority has the authority to submit a plan on behalf of the Tribe with prior review and approval by the Tribe, and

**BE IT FURTHER RESOLVED**, that this Resolution may be made a part of and incorporated into the Indian Housing Plans submitted by the TDHE on behalf of the Tribe, and

**BE IT FURTHER RESOLVED**, that this resolution and certification shall remain in effect with time limit subject only to the right of the Tribe, in its sole discretion, to revoke this certification. Should the Tribe revoke this certification, a copy of such revocation shall be sent to the Alaska Office of Native American Program, 949 East 36<sup>th</sup> Avenue, Suite 401, Anchorage, Alaska 99508-4399.
