ENVIRONMENTAL PROTECTION AGENCY (EPA) GRANT REQUEST

A RESOLUTION AUTHORIZING THE ALEUTIAN/PRIBILOF ISLANDS ASSOCIATION, INC. (A/PIA) TO APPLY FOR EPA FUNDS AND CONTINUE THE COMMUNITY ENVIRONMENTAL PROJECT.

WHEREAS, the Native Village of Sand Point is a federally recognized tribe in the Aleutian/Pribilof Islands region of Alaska; and


WHEREAS, A/PIA is the Alaska Native regional tribal organization authorized by tribal resolution to contract for and provide certain federal and state programs and services on behalf of tribal members of the Native Village of Sand Point; and

WHEREAS, the Qagan Tayagungin Tribal Council recognizes the importance of maintaining safe drinking water, sanitary sewage disposal, effective waste disposal and a clean environment for the general health and welfare of the people of the Native Village of Sand Point

NOW THEREFORE BE IT RESOLVED, that the Qagan Tayagungin Tribal Council hereby authorizes A/PIA to apply for funding from the Environmental Protection Agency to continue funding the Community Environmental Project.
