RESOLUTION NO. 04-01

**A RESOLUTION REQUESTING INDIAN RESERVATION ROADS
CONSTRUCTION AND 2% TRANSPORTATION PLANNING FUNDS FOR A
TRANSPORTATION PLANNING PROJECT.**

WHEREAS, the Qagan Tayagungin Tribe of Sand Point is a federally recognized tribe;
and

WHEREAS, the Qagan Tayagungin Council is the governing body of the tribe; and

WHEREAS, the Tribe qualifies for services and benefits under the Indian Reservation
Roads (IRR) Program; and

WHEREAS, the Tribe is updating its Long-Range Transportation Plan (LRTP) and the
IRR Inventory; and

WHEREAS, the BIA issued a Federal Register Notice on August 14, 2003, indicating
that critical resources are available for development of inventory data, long-range
transportation plans, transportation improvement programs, and other information
necessary to distribute the funds under the Tribal Transportation Allocation
Methodology; and

WHEREAS, developing the tribes Long-Range Transportation Plan, IRR inventory, and
providing information to the BIA for the implementation of the proposed Tribal
Transportation Allocation Methodology are tribal priorities; and

WHEREAS, all tribes in the state need to develop their IRR Inventory and LRTPs.

NOW, THEREFORE, BE IT RESOLVED, that the Qagan Tayagungin Tribal Council of
Sand Point request the BIA identify a transportation planning project in the FY2003 and
FY2004 IRR TIP for all tribes in the state that need to update their inventory data and
LRTPs; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Qagan Tayagungin Tribal
Council of Sand Point request that BIA provide no less that \$30,000 per tribe (\$15,000
per year for FY2003 and FY2004) for a transportation planning project funded out of the
IRR construction funds; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Qagan Tayagungin Tribal Council request that BIA provide FY2003 and FY2004 2% tribal transportation planning funds to the tribe; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Qagan Tayagungin Tribal Council request the BIA to identify transportation planning as a tribal priority and place transportation planning as a project in the FY2003 and FY2004 IRR TIP.

NOW, THEREFORE, BE IT FINALLY RESOLVED, that the Qagan Tayagungin Tribal Council of Sand Point intends to perform a transportation planning project under P.L. 93-638.
