A Resolution Authorizing The Qagan Tayagungin Tribe of Sand Point Applying to Extend The Bureau of Indian Affairs P. L. 93-638 Contract for Tribal Operations Starting FY 2005.

WHEREAS, The Qagan Tayagungin Tribe of Sand Point is a federally recognized tribe authorized with government to government status with the United States of America and:

WHEREAS, The Qagan Tayagungin Tribal Council is the governing body of The Qagan Tayagungin Tribe authorized by it's Constitution to act on the behalf of the Native Tribal Members regarding the contracting of Bureau of Indian Affairs Program Services; and

WHEREAS, The Qagan Tayagungin Tribal Council proposes to contract Program Code No. 39220 "Other Aid To Tribal Government" of the BIA Tribal Operations Contract afforded it under P. L. 93-638 with The BIA to provide services it's Tribal Members under the Tribal Operations Contract, with no changes in prior contract; and

WHEREAS, The Qagan Tayagungin Tribal Council authorizes Tribal President / Administrator, to negotiate and administer Contracts with the Bureau of Indian Affairs.

NOW THEREFORE BE IT RESOLVED, by the Qagan Tayagungin Tribal Council hereby proposes to contract a P. L. 93-638 Contract with The Bureau of Indian Affairs starting in FY 05 to provide services in accordance with the provisions set forth in the Tribal Operations Contract, to be awarded directly to The Qagan Tayagungin Tribe until rescinded.
