Resolution 07-12

A RESOLUTION OF THE Qagan Tayagungin Tribe SUPPORTING THE ALEUT MARINE MAMMAL COMMISSION (AMMC) AND APPOINTING A PRIMARY AND ALTERNATE REPRESENTATIVE TO THE COMMISSION.

WHEREAS, the Aleut Marine Mammal Commission (AMMC) was formed in May 1997 and incorporated under the State of Alaska in 1999 by the Aleut Tribes of Atka, Akutan, Belkofski, False Pass, King Cove, Nelson Lagoon, Nikolski, Sanak, Sand Point, Unalaska, and Unga of the Aleutian Islands and Alaska Peninsula to give the Aleut Communities a voice and the authority to work together for the conservation, well-being, and sustainable development of the marine mammal resources in the Aleutian Islands and Alaska Peninsula communities and to co-manage those resources with the National Marine Fisheries Service, US Fish and Wildlife Services and other state and federal marine management agencies; and

WHEREAS, the Aleut Marine Mammal Commission consists of tribally appointed representatives empowered by each appointing tribe to act on their behalf of matters concerning the marine resources in the Aleutian Islands and Alaska Peninsula region; and

WHEREAS, the Qagan Tayagungin Tribe is a member of the Aleut Marine Mammal Commission actively endorsing and supporting the mission and work of the AMMC; and

WHEREAS, the Qagan Tayagungin Tribe is a federally recognized tribe with a government to government relationship with the United States of America; and

WHEREAS, the Tribal Council has the authority to appoint and empower their representatives to act on matters relating to marine resources on the Aleut Marine Mammal Commission.

NOW THEREFORE BE IT RESOLVED, the Qagan Tayagungin Tribe hereby appoints Peter Devine as Primary Representative and Dick Jacobsen as Alternative Representative to represent the Qagan Tayagungin Tribe on the Aleut Marine Mammal Commission; and

BE IT FURTHER RESOLVED, to any agency, group, commission, other body or individual before which or to whom the Aleut Marine Mammal Commission may address itself, is hereby notified that AMMC is empowered to speak and act on behalf of the members of the Qagan Tayagungin Tribe on any and all matters related to or concerning all marine mammal resources in the Aleutian Islands and Alaska Peninsula region.

BE IT FURTHER RESOLVED, nothing in this resolution is intended to prevent cooperation among

AMMC and other commissions or groups through memoranda of agreements or otherwise.


