**A RESOLUTION SUPPORTING THE ALEUTIAN HOUSING AUTHORITY  
(AHA) APPLICATION FOR NEW HOUSING CONSTRUCTION PROJECT FOR  
AFFORDABLE HOUSING IN SAND POINT**

**WHEREAS**, AHA has been designated by the Qagan Tayagungin Tribe of Sand Point as their "Trially Designated Housing Entity" to administer a certain portion of NAHASDA funds received on behalf of the Tribe; and

**WHEREAS**, Sand Point certain residential properties located in the Meadows Subdivision which were purchased by AHA have utility infrastructure, foundations, and housing design plans in place to address an immediate need for two affordable housing units under a New Housing Construction Project; and


**WHEREAS**, the parties will cooperate in a joint effort to seek one-time federal stimulus funding, allocated in the Native American Housing Block Grant (NAHBG) under the American Recovery and Reinvestment Act (ARRA) to address the identified need and AHA will be the recipient of such funds for purposes of project management and administration:

**NOW THEREFORE BE IT RESOLVED**, that the Qagan Tayagungin Tribe of Sand Point hereby certifies support for the Aleutian Housing Authority (AHA) application for NAHBG funding under the ARRA; and

**BE IT FURTHER RESOLVED**; that to meet the match ceiling for this project, AHA is authorized to take any and all appropriate and necessary action to obligate land acquisition costs for the site purchases made with Qagan Tayagungin Tribe Tribal Needs funds in coordination with the Pauloff Harbor Tribe and the Unga Tribal Council, which Tribes are also located in Sand Point, for a total grant match of \$31,004.

**ADOPTED and APPROVED** this 11<sup>TH</sup> day of JUNE, 2009, by a vote of 5 in favor, 0 opposed, and 0 abstaining.
