RESOLUTION 12-04

A RESOLUTION AUTHORIZING THE APPLICATION FOR THE U.S. DEPARTMENT OF JUSTICE COORDINATED TRIBAL ASSISTANCE SOLICITATION.

WHEREAS, the Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point; and

WHEREAS, the Qagan Tayagungin Tribe of Sand Point understands the need to address the wellness and safety of the community of Sand Point as a whole, involving as many stakeholders as possible; and

WHEREAS, the Qagan Tayagungin Tribe of Sand Point desires to continue development, enhancement, and operations of our Tribal Court system which primary responsibility currently pertains to the protection of our children; and

WHEREAS, the Qagan Tayagungin Tribe of Sand Point knows to fully support the wellness and safety of our children we need to support the reentry of community members who may also be family members, and provide assistance in obtaining victim support services for our children and their families; and

WHEREAS, the Qagan Tayagungin Tribe of Sand Point feels to do so would require an extensive, multiagency strategic planning effort to coordinate efforts; and


WHEREAS, the Qagan Tayagungin Tribe of Sand Point would like to include in this strategic planning effort further development of our substance abuse and prevention program through continued development and support of cultural community enrichment programs and provision of retraining opportunities for youth and young adults who have already been involved in substance abuse to further reduce the recidivism of tribal members presenting in tribal and state courts for crimes related to substance abuse; and


