A RESOLUTION AUTHORIZING THE APPLICATION FOR THE NATIONAL PARK SERVICE HISTORIC PRESERVATION FUND GRANT

WHEREAS, the Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point; and

WHEREAS, the Qagan Tayagungin Tribe of Sand Point identifies the St. Nicholas Chapel is on the National Register of Historical Places and is located in the community of Sand Point; and

WHEREAS, the Qagan Tayagungin Tribe of Sand Point recognizes the historical and cultural contribution the St. Nicholas Chapel has played in the lives of the Qagan Tayagungin people and the community of Sand Point as a whole; and


WHEREAS, the St. Nicholas Chapel is suffering from exposure to the elements, and is poses a safety risk to those who utilize it, many of whom are Qagan Tayagungin members; and

NOW THEREFORE BE IT RESOLVED, that the Qagan Tayagungin Tribe of Sand Point hereby authorizes the application for the National Park Services Historic Preservation Fund Grant to compete a plan to preserve the St. Nicholas Chapel.


