**RESOLUTION 13-08**

**A RESOLUTION APPROVING THE LONG RANGE TRANSPORTATION PLAN  
DEVELOPED IN 2013 FOR THE BUREAU OF INDIAN AFFAIRS TRIBAL  
TRANSPORTATION PROGRAM**

WHEREAS, the Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point; and

WHEREAS, the Qagan Tayagungin Tribe qualifies for services and benefits under the Tribal Transportation Program; and

WHEREAS, the Bureau of Indian Affairs (BIA) is responsible for updating the Tribal Transportation Inventory; and

WHEREAS, the Tribe has identified a need to update its inventory; and

WHEREAS, the Tribe has identified these roads as vital to the general health and welfare of the native community and its economic development; and

WHEREAS, the Tribal Council has identified priorities for its Tribal Transportation Program; and

WHEREAS, the Tribe has updated its long range transportation plan accordingly.

## **Attachment 1**

### **Inventory Changes**

The changes to the Qagan Tayagungin Tribe's tribal transportation inventory has been reviewed and approved by the Qagan Tayagungin Tribal Council at the March 20, 2013 Regular Tribal Council Meeting:

- Add Route 23
- Divide Route 4 into sections 10, 20, and 30.
- Add section 40 to Route 4
- Divide Route 5 into section 10, and section 20
- Rename Route 6 Trailer Court
- Rename Route 8 Roadway Street
- Rename route 11 Little Sanak

NOW THEREFORE BE IT RESOLVED, that the Qagan Tayagungin Tribe of Sand Point hereby approves the 2013 Long Range Transportation Plan.

BE IT FURTHER RESOLVED, the Tribe hereby requests the BIA to add the routes, and make the inventory changes detailed in the Long Range Transportation Plan, and detailed in attachment 1 of this resolution.
