**A RESOLUTION TO REQUEST FUNDS FOR A P.L. 93-638 CONTRACT FROM THE U. S. BUREAU OF INDIAN AFFAIRS (BIA) TO ADMINISTER A TRIBAL SCHOLARSHIP AND JOB PLACEMENT AND TRAINING PROGRAM UNDER THE AID TO TRIBAL GOVERNMENTS PROGRAM.**

WHEREAS, the Qagan Tayagungin Tribe is a sovereign federally recognized Tribe with government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribe is the governing body of the Qagan Tayagungin Tribe of Sand Point; and

WHEREAS, the Qagan Tayagungin Tribe qualifies for services and benefits as authorized by the Snyder Act of November 2, 1921 25 USC 13 and subsequent legislation an 25 CFR part 26; and

WHEREAS, the Qagan Tayagungin Tribe recognizes the critical importance to tribal members and our economy to be able to assist Tribal members in pursuing further education as well and as providing job placement and training services; and


WHEREAS, the Qagan Tayagungin Tribe desires to spend up 40% of our funds to complete functions in making scholarship grants for higher education to Tribal students; and

WHEREAS, the Qagan Tayagungin Tribe desires to spend up to 60% of our funds assisting tribal members who have skills to obtain and retain gainful employment; and provide career counseling, assessment, recommend training institutions to properly prepare applicants for entry into their career field and prepare applicants for gainful employment; and

NOW, THEREFORE BE IT RESOLVED that the Qagan Tayagungin Tribe hereby requests to enter into a P.L. 93-638 contract for FY2014-2017 to provide Tribal Scholarship, Job Placement, and training services to eligible tribal members as authorized by the Snyder Act of November 2, 1921 25 USC 13 and subsequent legislation, and 25 CFR part 26 and authorizes the President to execute all documents necessary to enter into this P.L. 93-638 contract.
