### **RESOLUTION 16-04**

#### **A RESOLUTION ANNOUNCING INTENT TO PARTICIPATE IN THE P.L. 102-447 ACT INTEGRATING EMPLOYEMENT AND RELATED PROGRAMS THROUGH THE ALEUTIAN PRIBILOF ISLANDS ASSOCIATION, INC.**

WHEREAS, the Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point; and

WHEREAS, the Aleutian Pribilof Islands Association exists to serve the socioeconomic needs of the Alaskan Natives and American Indians living in the Aleutian Pribilof Island region; and

WHEREAS, the Aleutian Pribilof Islands association is committed to providing programs in the region in areas of Child Care Development fund (CCDF), employment, training and related programs; and

WHEREAS, the administrative and operational overlapping resulting from varied and diverse regulations and requirements of differing funding sources have made the smooth, efficient cost effective operation difficult which ultimately can have an adverse effect of services delivered to village clients; and

WHEREAS, Congress, through P.L. 102-447, the Indian Employment, Training, and Related Services Demonstration Act of 1992, has attempted to simplify this bureaucratic morass by allowing Tribes and Alaska Native Organizations to consolidate separate employment and training related services and programs into a single comprehensive program; and

WHEREAS, the Qagan Tayagungin Tribe approves of the Aleutian Pribilof Islands Association's integrating services included in the P.L. 102-447 for the Child Care Development Fund for the benefit of its' Tribal Members.

NOW, THEREFORE, BE IT RESOLVED, that the Qagan Tayagungin Tribe approves of the Aleutian Pribilof Islands Association to operate the Child Care Development Fund (CCDF) on behalf of the Qagan Tayagungin Tribe through P.L. 102-447 for FY16
