WHEREAS, the Tribe recognizes the high cost of energy in Sand Point is detrimental to the business community and quality of life in the community; and,

WHEREAS, the RACEE Competition aims to give Sand Point the tools and resources to help implement strategies to combat these high-cost energy issues; and,

WHEREAS, the Tribe was a partner and joint-applicant on the previous RACEE applications, and is a partner on this Phase 3 application, and

WHEREAS, the relevant energy strategies will occur on Indian Land, owned by the Shumagin Corporation, and will therefore positively impact our tribal members.
