**A RESOLUTION SUPPORTING THE ALEUTIAN PRIBILOF ISLANDS ASSOCIATION'S SUBMISSION OF AN APPLICATION TO THE ADMINISTRATION FOR NATIVE AMERICANS, NATIVE AMERICAN LANGUAGE PRESERVATION & MAINTENANCE PROGRAM, FUNDING OPPORTUNITY NUMBER HHS-2018-ACF-ANA-NL-1342, PRIMARY CFDA NUMBER 93.587**

WHEREAS, the Qagan Tayagungin Tribe is a federally recognized tribe in the Aleutian Pribilof Islands region of Alaska; and,

WHEREAS, the Aleutian Pribilof Islands Association, Inc. is a regional non-profit tribal organization authorized by tribal resolution to contract for and provide certain federal and state programs and services on behalf of the Qagan Tayagungin Tribe; and,

WHEREAS, the Aleutian Pribilof Islands Association, Inc. currently operates a regional cultural heritage program and has a demonstrated history of administering programs and services that benefit tribal members and exists to promote the overall economic, social, cultural, health and environmental needs of the Unangax (Aleut) people; and,

WHEREAS, our language, Unangam tunuu, is a valuable component of our culture and the Qagan Tayagungin Tribe strongly supports Unangax cultural heritage preservation efforts; and,

WHEREAS, the Administration for Native Americans, Native American Language Revitalization and Maintenance program, 93.587 has a Funding Opportunity Announcement, HHS-2018-ACF-ANA-NL-1342, aimed at supporting Native communities; and,

WHEREAS, the Aleutian Pribilof Islands Association, Inc. Board of Directors on behalf of the thirteen (13) federally recognized tribes of the Aleutian Pribilof Islands region, supports Aleutian Pribilof Islands Association, Inc. to take any and all such action as may be required to apply for, and if awarded, administer the Administration for Native Americans Native American Language Preservation and Maintenance grant, 93.587; and,
