Qagan Tayagungin Tribe of Sand Point
SUBJECT: Aleut Indian Judgment Funds Docket 369

WHEREAS, the Qagan Tayagungin Tribe of Sand Point is a federally recognized tribe and is one of the villages sharing in the distribution of the Aleut Indian Judgment funds further known as Docket 369, and

WHEREAS, the Qagan Tayagungin Tribe is the allocated Trustee to these funds under the Bureau of Indian Affairs Juneau Area Office, and

WHEREAS, the Qagan Tayagungin Tribe elected to use a portion of the settlement funds toward business development in a joint effort with the Aleutian East Borough,

WHEREAS, the Qagan Tayagungin Tribe will share in the venture by investing cash towards the business project and,

NOW THEREFORE BE IT RESOLVED that the Qagan Tayagungin Tribe of Sand Point requests the Bureau of Indian Affairs to withdraw from its proportionate share of the Aleut Indian Judgment Funds, the amount of \$250,000.00 to be used for the purpose of helping to fund the business development of office(s), meeting room, and cultural area, and


BE IT FURTHER RESOLVED, that the Qagan Tayagungin Tribe directs the Bureau of Indian Affairs to deposit the amount specified above, to the account of First National Bank of Anchorage Bank, Qagan Tayagungin Tribe, Main Street 9, P.O. Box 447, account No. 0112544 2 immediately upon receipt of this resolution .

BE IT FURTHER RESOLVED, that the Qagan Tayagungin Tribe submits the accompanying Resolution 96 - 11 the proposed agreement with Aleutian East Borough until a formal detailed specific plan and agreement is submitted for the use and expenditure of its share of the Aleut Indian Judgment Funds for approval by the Area Director, Bureau of Indian Affairs, Juneau Area Office.

CERTIFICATION


