WHEREAS: The Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government to government status with the United States of America; and

WHEREAS: The Qagan Tayagungin Tribal Council is the governing body of the Qagan Taygunjin Tribe of Sand Point authorized by its constitution to act on behalf of its tribal members; and

WHEREAS: The Qagan Tayagungin Tribe is interested in having representation at the 1998 Village Participation Conference in Juneau, March 23-27, 1998; and

WHEREAS: The Qagan Tayagungin Tribal Council has selected and approved its Tribal President Edith I. Jacobsen to represent our community.


