## **RESOLUTION 98-05(A)**

### **A RESOLUTION OF THE QAGAN TAYAGUNGIN TRIBAL COUNCIL SUPPORTING THE ALEUTIAN PRIBILOF ISLANDS ASSOCIATION IN OBTAINING EPA/ IGAP GRANT.**

WHEREAS, The Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government to government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point authorized by its Constitution to act on behalf of its tribal members; and

WHEREAS, the Tribal Council is concerned about environmental protection as a health risk to all people living in the community of Sand Point in the Aleutian/Pribilof Islands Region; and

WHEREAS, the Tribal Council understand the importance of all tribes in the Aleutian/Pribilof Islands Region coordinating efforts to address environmental concerns; and

WHEREAS, the Tribal Council recognizes the value of individual tribes working cooperatively with a tribal consortium so that all tribes, the Environmental Protection Agency, and the Aleutian/Pribilof Islands Association, Inc., will maintain consistent standards in all EPA authorized programs; and


WHEREAS, the Qagan Tayagungin Tribal Council desires a more cost effective and cost efficient approach for the tribes wishing to establish such programs; and

WHEREAS, the Aleutian/Pribilof Islands Association, Inc., has been recognized by the federal government as the Regional Non-Profit body of the Aleut people under the Indian Self-Determination Act as an agency to act on behalf of the tribes by the U.S. Environmental Protection Agency to assist in managing environmental protection programs under the Indian General Assistance Program; and

NOW THEREFORE BE IT RESOLVED, that the Qagan Tayagungin Tribal Council asks for the Aleutian Pribilof Islands Association, Inc.'s Executive Director, on its behalf, to pursue grant funds from the United States Environmental Protection Agency Region 10 for the Indian General Assistance Program to assist the Qagan Tayagungin Tribal Council establish environmental programs for the Qagan Tayagungin Tribe in Sand Point.


