RESOLUTION 98-13

A RESOLUTION OF THE QAGAN TAYAGUNGIN TRIBE OF SAND POINT AUTHORIZING THE ALEUTIAN/PRIBILOF ISLANDS ASSOCIATION, INC. TO APPLY FOR GRANTS ON BEHALF OF THE QAGAN TAYAGUNGIN TRIBE FROM THE DEPARTMENT OF DEFENSE FOR THE MITIGATION OF ENVIRONMENTAL IMPACTS TO INDIAN LANDS DUE TO DEPARTMENT OF DEFENSE ACTIVITIES.

WHEREAS; The Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government to government status with the United States of America, and

WHEREAS; the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point, and

WHEREAS; the Qagan Tayagungin Tribal Council is concerned about contamination of the environment which the tribe depends heavily on for subsistence, and

WHEREAS; World War II and Cold War US Department of Defense (DOD) facilities that possess hazardous wastes still exist within the Aleutian/Pribilof and Shumagin Islands Region; and

WHEREAS; the Qagan Tayagungin Tribe of Sand Point desires to participate in a Cooperative Agreement with the DOD to develop effective solutions for environmental hazards from military facilities, and

WHEREAS; the Qagan Tayagungin Tribe of Sand Point understands the importance of all tribes in the Aleutian/Pribilof Islands Region coordinating efforts with the DOD to have a healthy environment; and

WHEREAS; the Qagan Tayagungin Tribe of Sand Point is a member of the Aleutian/Pribilof Islands Association, Inc. (A/PIA), an Alaska Native non-profit organization providing services to the Aleut people of the region, generally pursuant to authorizing resolutions of member tribal governments.

NOW THEREFORE BE IT RESOLVED, that the Qagan Tayagungin Tribe of Sand Point hereby authorizes the Aleutian/Pribilof Islands Association, Inc. to receive and to administer grants on behalf of the Qagan Tayagungin Tribe from the Department of Defense for the Mitigation of Environmental Impacts to Indian lands Due to Department of Defense Activities.


BE IT FURTHER RESOLVED, the Aleutian/ Pribilof Islands Association, Inc. will notify and provide the Qagan Tayagungin Tribe copies of all DOD grant documents whereby A/PIA receives grant funding whether in whole or in part on the behalf of the Qagan Tayagungin Tribe whether.

BE IT FURTHER RESOLVED this resolution is effective upon adoption and will remain in effect until such time that it is withdrawn by tribal resolution.
