**RESOLUTION 99-15**

**A RESOLUTION OF THE QAGAN TAYAGUNGIN TRIBE REQUESTING THE UNITED ALEUT NATION COUNCIL CONTINUE TO RECOGNIZE THE QAGAN TAYAGUNGIN TRIBE AS AN ACTIVE MEMBER IN THE UNITED ALEUT NATION.**

WHEREAS, The Qagan Tayagungin Tribe of Sand Point is a sovereign federally recognized tribe with government to government status with the United States of America; and

WHEREAS, the Qagan Tayagungin Tribal Council is the governing body of the Qagan Tayagungin Tribe of Sand Point, and

WHEREAS, the Qagan Tayagungin Tribe recognizes the United Aleut Nation can provide a united voice in protecting the rights of the Aleut people, and

WHEREAS, the Qagan Tayagungin Tribe desires to remain an active member of the United Aleut Nation and to work in unison with the other Aleut tribes that make up the Aleut Region to protect the rights of the Aleut people, and

WHEREAS, the Qagan Tayagungin Tribe believes the President or Chief of each Tribe should be the Official Delegate to represent each tribe on the United Aleut Nations Council, and


WHEREAS, the Qagan Tayagungin Tribe desires to be a part of the development of a new Joint Powers Agreement that defines and governs the authority of the United Aleut Nation Council that can be agreed upon and approved by all Aleut tribes in the Aleut Region.

NOW THEREFORE BE IT RESOLVED, requests the United Aleut Nation Council continue to recognize the Qagan Tayagungin Tribe as an active member in the United Aleut Nation, and


BE IT FURTHER RESOLVED, the Qagan Tayagungin Tribal Council hereby appoints the President of the Qagan Tayagungin Tribe to be its Official Delegate with the authority to the speak on behalf of the Qagan Tayagungin Tribe on the United Aleut Nation Council, and

BE IT FURTHER RESOLVED, the Qagan Tayagungin Tribe requests the United Aleut Nation develop a new Joint Powers Agreement to govern the authority of the United Aleut Nation that is agreeable to all Aleut tribes in the United Aleut Nation.

PASSED AND APPROVED BY A DULY CONSTITUTED QUORUM OF THE QAGAN TAYAGUNGIN TRIBAL COUNCIL THIS 8TH DAY OF NOVEMBER, 1999. VOTE: 5 in favor; 0 opposed; 0 abstained.
